

Disney Competition Rules together with the General Terms & Conditions for Prize Draws and Competitions - ***Disney Destinations International, a division of The Walt Disney Company Limited – ‘Disney Parks Mini Duos’ Competition shall hereafter be the (“Terms & Conditions”)***

The Walt Disney Company Limited (“We” or “Disney”), is offering three (3) pairs of children aged between (and including) 4 and 11 years old (“Mini Duos”) the chance to win one of three (3) holidays at either Disneyland Paris, Walt Disney World® Resort in Florida or onboard Disney Cruise Line (each a “Holiday” or the “Prize”) with their family (the “Competition”).
