

Terms and Conditions for the Storytelling+: Bootcamp 2019

*These following entry terms and conditions (“**Entry Terms**”) are for the activity known as “Storytelling+: Bootcamp 2019” (“**Activity**”) to be conducted by The Walt Disney Company (Southeast Asia) Pte. Limited (“**Disney**”) and shall be binding on each and every person registering for the Activity (“**Registrant/you/your**”). These Entry Terms are in addition to the Global Terms of Use, Privacy Policy and Supplemental Privacy Policy for Singapore, which are incorporated herein by reference and are available on www.disney.sg. The Entry Terms, Global Terms of Use, Privacy Policy and Supplemental Privacy Policy for Singapore are collectively referred to as the “**Terms and Conditions**”, which are available on www.disney.sg. In the event of any conflict between the Entry Terms on one hand and the Global Terms of Use, Privacy Policy and Supplemental Privacy Policy for Singapore on the other hand, the Entry Terms below shall prevail.*

1. Eligibility:

Entry to enable registration for the Activity is open for such individuals who fulfill the following criteria:

- 1.1 The Registrant must be 18 (eighteen) years old and above;
- 1.2 The Registrant must know how to read, write and speak in English language;
- 1.3 The Registrant shall not be a director, officer or an employee of Disney or its affiliated companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and associate vendors.

If the Registrant does not meet all the above criterions specified above, they shall not be entitled to take part in the Activity and Disney reserves the right to forthwith disqualify such Registrant and his/her application forthwith.

2. Registration Period:

Registration for the Activity shall be open and valid only from 00.00 hours on July 24th, 2019 and shall remain valid until 23.59 hours on August 19th, 2019 or such time as Disney may declare on its website <https://www.disney.sg/storytelling-bootcamp> (“**Website**”) (“**Registration Period**”). Disney may alter the duration of the Registration Period at its sole and absolute discretion.

3. Registration Mechanism:

Registrants may register for the Activity by accessing the registration page located on the Website i.e. <https://www.disney.sg/storytelling-bootcamp> wherein the Registrant may register for the Activity with the submission of the relevant information and documents. If shortlisted, the Registrant may have the opportunity to attend an experiential learning activity, by way of an exciting [two-day] boot camp held on September 14th and 15th, 2019 tentatively at The Working Capitol, Singapore, that brings together prominent storytellers in popular entertainment and may offer a chance to meet, interact and be inspired by renowned creative leaders from the film and media world including from Disney, Marvel and Lucasfilm.

3.1 Account Creation

You may register in the Activity by making an account on the Website by entering your particulars. Your e-mail ID will become their unique identification code.

3.2 Form Submission

In addition to the making of the account, you will be required to fill up and submit/upload the following two forms:

- A Individual Particulars including your resume/professional summary; and
- B Release Form,

(hereinafter individually referred to as the Form and collectively referred to as the "Forms") available on the Website in the mode and manner prescribed therein. You agree and undertake that all information provided in the Forms is true and correct.

3.3 **Interview Process**

You agree that in addition to the creation of the account and submitting and uploading the Forms, Registrant will opt for the interview date and time slot. Disney will confirm through the Registrant's email address provided in the registration process the interview date and time and in case of non-availability of your preferred date and time will offer only [2/3] alternate date and time for you to choose. You will bear the travel and accommodation costs for appearing at the interview and participating at the Activity. In the event you are unable to travel or remain present for the interview at location(s) specified by Disney, then Disney at its sole discretion, shall arrange for an interview at such date, time and place as decided by Disney.

It is clarified that for the purpose of qualifying for the Activity, you will have to complete all the steps being account creation, form submission and interview process.

In case of non-submission of any of the Form/information or if in Disney's opinion any information provided in the Forms turns out to be false or incorrect, Disney has the right at its sole discretion to disqualify the submission and the Registrant shall not be entitled to object to the same.

Registration by any person for the Activity will be deemed to be taken as acceptance of the Terms and Conditions and the terms as contained in the Forms. Registration by any method other than set forth in this section are void and any use of automated or programmed methods of effecting registration is prohibited. Each person is allowed to register only one (1) time. In the event of more than one (1) registrations are received from the same Registrant, the earliest entry by such Registrant shall qualify for selection (if any) of the Registrant for the Activity. In the event that more than one (1) registration is received from a Registrant with similar personal particulars, then the earliest post from such Registrant shall qualify for the selection (if any) of the Registrant for the Activity. By registering for this Activity, each Registrant represents and warrants that he/she is not subject to any agreement or arrangement that would interfere with his/her participating in the Activity, and is granting all the rights granted under the Terms and Conditions. It is clarified that the registration and submission of information by a Registrant does not guarantee participation in the Activity.

4. **Selection Criteria:**

Selection of the Registrants for the Activity will be on first-come-first-serve basis of first 65 (sixty five) Registrants and preference will be given to Singapore citizens or Singapore permanent residents, who have completed the process set out in paragraph 3 and are not disqualified under the Terms and Conditions ("Participants") shall be deemed to be available for the Activity on the scheduled dates.

Disney shall inform the Participants of their selection to participate in the Activity by email submitted by the Participants. It is hereby clarified that all decisions of Disney and/or interviewers with regard to the Participants shall be final and binding and no correspondence shall be entered into or entertained on any decision made by Disney in this regard. It is hereby clarified that the number of Participants may be increased or decreased at the sole and absolute discretion of Disney and the criteria for increase and decrease of Participants shall be decided by Disney at its sole discretion.

Selection of the Registrants for the Activity shall be subject to each executing such agreements, documents as may be required by Disney, from time to time. It is hereby agreed and confirmed by the Participant that any content at any stage of development developed by the Participant/s during the registration, interview and/or Activity shall be deemed to be a work-made-for-hire/ commissioned at the instance of Disney and each Participant undertakes to execute necessary documents, agreements and take all steps to give effect to this understanding, as per the requirement of Disney. In the event a Participant does not execute documents, agreements, as per the requirement of Disney, Disney reserves the right to disqualify such Participant.

The Participants agree to adhere by all the instructions given by the Activity/ course instructor/guest lecturer(s)/panelists/Disney. Without prejudice to the foregoing, each Participant undertakes to adhere to any guidelines, policies of Disney during the time of the Activity.

At the time of rejecting a registration, a generic rejection email shall be communicated by Disney by way of email to the email address provided by the Registrant. Participants will be required to submit additional documentation as required by Disney at its sole discretion.

5. **Disqualification Criteria:**

Disney at its sole discretion shall disqualify the Registrant/ Participants if:

- 5.1 Any of the information and documents submitted by the Registrant /Participants is untrue or is believed by Disney to be untrue;
- 5.2 The Registrant/ Participants have not accepted or complied with the Terms and Conditions or is in violation of the Terms and Conditions, or is otherwise ineligible to enter or participate in the Activity;
- 5.3 If the Registrant's/Participant's conduct hampers the operation of the Activity (in each case as determined in Disney's sole and absolute discretion);
- 5.4 Registrations which in the opinion of Disney are incomplete or which are submitted and uploaded in contravention to the terms set out in the Website or which have been submitted after the Registration Period, will not be considered as valid registration by Disney for the purposes of the Activity; and
- 5.5 Any of the representations and/or warranties made by the Registrant /Participants is untrue or is believed by Disney to be untrue.

6. **Participant Information:**

Registrant/ Participant's participation in the Activity is conditional upon you consenting to Disney and its affiliated, group companies and business units (collectively, "**WDSEA Group**") collecting, using, disclosing, transferring and processing your personal data for the following purposes: (i) registration for Storytelling+: Bootcamp (ii) consumer research, promotional and marketing purposes. By participating in this Storytelling+: Bootcamp 2019, you consent to the collection, use, disclosure, transfer and processing of your personal data for the purposes listed above. 7. **Release:**

The Registrant/Shortlisted Registrant's/Participant's agree and acknowledge that:

- 7.1 Disney shall not be liable for a minor registering and/or participating in the Activity without a parent's or guardian's supervision. Parents/guardians of such minors shall be liable for damages or losses occurred due to activities or action of their wards and are legally bound by any acts/deeds/violations of the Terms and Conditions.
- 7.2 Disney is not liable for any harm caused by or related to the theft of Registrant's/ Participant's email account, email address, personal information, disclosure of email account, or Registrant's/ Participant's authorization to allow another person to use and operate your email account. Furthermore, the Registrants/ Participants are solely and entirely responsible for any and all activities that occur under their email account at all times. Disney will not be liable in any manner whatsoever for Registrants/ Participants losses caused by any unauthorized use of a Registrant's/ Participant's email account, you may however be liable for the losses suffered by Disney or others due to such unauthorized use. In registering for the Activity, Registrants/ Participants agree, where if information is requested, you will provide true, accurate, current, and complete information about yourselves.
- 7.3 Disney, all participating sponsors (if any) and any of their respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, employees and agents shall not

be responsible or liable for: (a) Any problem, loss or damage of whatsoever nature suffered by any party due to any delay and/or failure (including lost entries, mail delay or loss) in registering for or participating in the Activity as a result of any communication error, interruption, human error and/or failure by Disney and/or any third party; (b) Any problem, damage or loss of whatsoever nature to any person, resulting from his/her registration for and/or participation in the Activity; (c) Any error (including without limitation error in notification to Participants), omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of, or unauthorized access to entries, or entries lost or delayed whether or not arising during operation or transmission; or (d) Any changes made by Disney or any third party suppliers or sponsors; or (e) any electronic, hardware, software, network, internet, or other computer- or communications-related malfunctions or failures or any disruptions, injuries, losses or damages caused by events beyond the control of Disney. To the fullest extent permitted by law, Disney and its associated companies and agents exclude responsibility and all liabilities arising from any postponement, cancellation, delay or changes to the Activity beyond Disney's reasonable control and for any act or default of any third-party supplier.

- 7.4 By registering for the Activity, Registrants/ Participants on their own accord and on behalf of their participating family members shall indemnify Disney, participating sponsors and any of their respective parent companies, subsidiaries, affiliates, directors, officers, employees and agencies and hereby release them from any liability of whatsoever nature, and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Registrants/ Participants registering and participating in the Activity including but not limited to any violation of these Terms and Conditions and/or any third party rights.
- 7.5 Registrants/ Participants agree to defend, indemnify and hold harmless Disney, its affiliates and their respective officers, directors, employees and agents, from and against any and all claims, damages, obligations, losses, liabilities, costs or debt, and expenses (including but not limited to attorney's fees) arising from: (i) your use of and access to the Website, your participation in the Activity; (ii) the contents of the registration, forms uploaded and submitted by you and any third party claims arising out of the same; (iii) your violation of any term of these Terms and Conditions (iii) your violation of any third party right, including without limitation any copyright, property, or privacy right; or (iv) any claim that any of your actions/omissions have caused damage to a third party; or (v) if any representation, warranty made by you turns to be untrue, false and in accurate.
- 7.6 Disney is in no manner whatsoever responsible and/or shall not be held liable in any manner whatsoever, for any direct or indirect loss, injury damage including physical injury, death, mental and/or emotional trauma caused to the Registrants/ Participants in any manner whatsoever, in relation to the registration mechanism, account creation, form submission, interview process, Activity and/or any matters arising out of the Terms and Conditions.

8. **Governing Law and Dispute Resolution:**

The Activity and the Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore, without regard to the conflict of law's provisions therein. By registering and participating in the Activity, the Registrants/ Participants irrevocably submit to the exclusive jurisdiction of the courts of Singapore for the purpose of resolving any dispute, disagreement, difference, controversy or claim of any kind whatsoever arising under, out of, relating to or in connection with this Activity or these Terms and Conditions.

The Terms and Conditions are not intended to confer rights on any third party, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap 53B) of Singapore or otherwise, and no third party shall have any right to enforce any provision of these Official Rules.

None of the above paragraphs limits any other.

9. **Miscellaneous:**

Disney reserves the right to terminate the arrangement with the Participant anytime during the Activity, without providing any reason for such termination. In consideration of the huge monies, resources and time invested by Disney in providing the Participants with an opportunity/platform to be associated with the Activity, professional workshops and expertise, the Participants shall not be entitled at any point of time during the Activity Period to leave or discontinue the Activity for any reason whatsoever.

Registrants/ Participants agree to be bound by these Terms and Conditions and by the decisions of Disney, which are final and binding in all respects. Disney in its sole discretion, reserves the right to change these Terms and Conditions at any time and/or to suspend or cancel the Activity including if any act of God, viruses, bugs, unauthorized human intervention or other causes beyond Disney's control affect the administration, security or proper conduct of the Activity. The Participants agree and acknowledge that the dates and the details of the Activity may be changed at Disney's discretion without prior notice. Disney may abandon, cancel, withdraw the Activity or change the nature of the Activity, at any time it deems fit, without giving any prior notice to the Participant(s). The Participant represents and warrants that he/she does not have any criminal conviction or an arrangement or other contract that prevents the Participant from participating in the Activity.

The Participant agrees to do any and all acts and execute any and all documents in such manner and at such locations as may be required by Disney in Disney's sole and absolute discretion. The Participant shall at all times comply with applicable laws, rules and regulations including without limitation the Terms and Conditions, the anti-corruption and anti-bribery laws and applicable provisions of the Foreign Corrupt Practices Act of United States of America and UK Anti-Bribery Act etc. The Registrants/ Participants shall not, at any time before, during or after the Activity make any defamatory, derogatory statements about Disney and/or its business. All costs, expenses, taxes, duties, charges, license fees, insurance and/or levies in relation to the registration and participation in the Activity shall be borne solely by the Registrants/Participants unless otherwise expressly mentioned herein.

If any provision of these Terms and Conditions is deemed invalid by any law or a court of competent jurisdiction, the invalidity of such provision shall not affect the validity of the remaining provisions of these Terms and Conditions, which shall remain in full force and effect. No waiver of any term of these Terms and Conditions shall be deemed a further or continuing waiver of such term or any other term, and Disney's failure to assert any right or provision under these Terms and Conditions shall not constitute a waiver of such right or provision. Your use of the Website following any amendment of these Terms and Conditions will signify your assent to and acceptance of its revised terms.

The Registrants/ Participants acknowledge that the representations and warranties, indemnities, governing law, dispute resolution, warranty disclaimer, releases and such other provisions which by their nature should survive, shall survive the completion of the Activity.

Nothing herein shall be deemed to create a partnership, agency or an employer-employee relationship between the Registrants/ Participants and Disney.
